### **CONSIGNMENT CONTRACT TERMS AND CONDITIONS**

This Contract ("Contract") is by and between Seller (AKA "Consignor"), whose name is specified in Box 1, and Printer Strategies LLC (AKA "Consignee"), a Missouri limited liability company ("PS") and is dated as of the date first signed below by Seller.

The parties agree as follows:

1. Consignor engages Printer Strategies to sell the items listed in Box 10 (the "Lots") online via auction (the "Website").  
PS shall list the Lots on the Website in an online auction (the "Auction").  
PS shall handle the relationship between potential buyers and winning bidders.  
PS in its sole discretion may charge and collect a Buyer's Premium, payable by the winning bidders of the Lots.
2. PS shall advertise the Auction via email to its user base at least once when the auction opens and once shortly before the auction closes.  
PS at its sole discretion may choose to advertise some, all, or none of the Lots on this email advertisement.

### **INITIAL THE FOLLOW STATEMENTS TO INDICATE ACCEPTANCE**

3. Consignor agrees to grant PS exclusive right to list equipment for a period of 45 days from the date of the signed agreement.

4. Consignor agrees to enter in to a contract for sale of the Lots with each Buyer at the close of the Auction.  
\_\_\_\_\_ Once Lots are added to the Auction, Consignor may not withdraw Lots, nor sell them to anyone other than the highest bidder.
5. Consignor is the sole owner of the Lots and has good title and right to sell all the Lots.  
\_\_\_\_\_ Consignor represents and warrants that there are no existing liens attached to any of the Lots.
6. Consignor agrees to sell all the Lots in a reserve auction with a minimum bid of \$1.  
\_\_\_\_\_ PS may not sell any Lots at prices below their respective reserve prices as specified in Box 12 without written consent from Seller.
7. Should Consignor (You) sell Equipment outside Agreement term; Consignor will remit \_\_\_ % of the sales price to Consignee.
